





Special Treatments: Accepted Qualifications

Qualifications gained overseas will have to be submitted by the therapist/practitioner to UK ENIC <u>www.enic.org.uk</u> – for a qualification comparison to be completed and a statement of comparability provided to support application to provide those treatments.

The council has produced a summary of the qualifications and training requirements along with the special treatments that they cover. This list is not exhaustive and is provided by way of an example only. If a qualification does not appear it is for the licence holder to take necessary steps to satisfy himself or herself that the training certificate evidences necessary competence to provide a specific special treatment. You can contact the Licensing Team for further clarification.

Where there are no nationally recognised qualifications for a particular special treatment, or where a special treatment practitioner is relying on experience and training, they should expect to be provided with:

- •Evidence of relevant training, and
- •Reference and evidence of past work and proof of when and where their apprenticeship or training was undertaken.

At present there are no nationally or internationally recognised qualifications for the following special treatments: •Body piercing;

- •Floatation tanks;
- 3•Tattooing; and
- •Ultra violet tanning.
